## **RESOLUTION NO. 10-16**

RESOLUTION OF THE BOARD OF DIRECTORS OF RUNNING SPRINGS WATER DISTRICT, ON BEHALF OF ITS FIRE DEPARTMENT, CALLING AN ELECTION ON NOVEMBER 8, 2016, TO SUBMIT TO THE VOTERS OF THE DISTRICT A MEASURE TO ADJUST THE MAXIMUM AMOUNT OF THE AVAILABILITY CHARGE FOR LOCAL FIRE PROTECTION AND EMERGENCY MEDICAL SERVICES AND REQUESTING CONSOLIDATION WITH THE STATE-WIDE ELECTION

WHEREAS, on June 15, 2016, this Board of Directors adopted Ordinance No. 45 of the Running Springs Water District, on behalf of its Fire Department (hereinafter the "Running Springs Fire Department"), Section 1 of which approved an adjustment in the maximum amount of the Running Springs Fire Department's annual availability charge for local fire protection and emergency medical services assessed upon improved real property to \$146 per unit of benefit as defined in the Uniform Building Code, subject to approval by at least two-thirds of the District's voters at an election thereon, with the form of the ballot measure to be set forth in the resolution calling the election;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Running Springs Water District on behalf of its Fire Department as follows:

1. Pursuant to the authority set forth in Government Code Section 53978, and as otherwise provided by law, an election is hereby called within the District's boundaries on November 8, 2016, to submit to the voters the following measure:

Shall the maximum annual availability charge on each improved lot or parcel of property within Running Springs Water District, not otherwise exempt, for fire suppression and emergency medical, ambulance and advanced life support services provided by the Running Springs Fire Department be adjusted from \$65 to an

amount not to exceed \$146 per unit of benefit beginning in 2017?

2. Pursuant to the requirements of Section 10403 of the California Elections

Code, the Board of Supervisors of the County of San Bernardino is hereby requested to

consolidate the election with the state-wide election to be conducted on Tuesday, November 8,

2016. The election will be held and conducted in the manner prescribed by Elections Code

Section 10418. The Board of Supervisors is requested to issue instructions to the Election

Department of the County of San Bernardino to take any and all steps necessary for conducting

the consolidated election.

3. Written arguments for and against the measure may be submitted on or

before the deadlines established by the District's election official, in the manner provided by law.

4. The District recognizes that additional costs will be incurred by the

County of San Bernardino in conducting this consolidated election, and hereby confirms that the

District will reimburse the County for any such costs.

5. The Secretary of the Board of Directors is hereby directed to file a

certified copy of this resolution with the Board of Supervisors of San Bernardino County and

with the Election Department of the County of San Bernardino.
